Anastasia Golubtsova has a kandidat degree in philology and is a senior research fellow at the Institute of World Literature of the Russian Academy of Sciences (Moscow, Russia). Her area of research includes Italian literature of the 19th and 20th century, Italian Avant-garde and Neo-avant-garde, Russian – Italian literary relations.

Giuseppe Ghini is Professor of Russian Literature at the University of Urbino since 1993; Fellow of the Institute for Research in the Humanities, University of Wisconsin, Madison (1997-98); Visiting scholar, Davis Center for Russian and Eurasian Studies, Harvard University (2003); Member of Associazione Italiana degli Slavisti. L'uomo nell'uomo*, Milano, ARES, 2014) and more than 60 articles.

Panayot Karagyozov is Professor of Slavic Studies at Sofia University, Bulgaria. He is the author of *The Self-consciousness of Letters. Historiography of Slavic Literatures* (Sofia, 1996); *Past Slavs Today* (Sofia, 1997); *Slavic Saint Martyrs. Sainthood and Canonization; Chronology and Typology; Criticism and Apology of Slavic Martyrdom* (Sofia, 2006).

Roman Katsman, PhD, is an Associate Professor at the Department of Literature of the Jewish People in Bar-Ilan University, Israel. He is an author of *Nostalgia for a Foreign Land: Studies in Russian-Language Literature in Israel* (2016), *Literature, History, Choice: The Principle of Alternative History in Literature* (2013), and other books and articles. Among his main research interests are modern and contemporary Hebrew literature (S. Y. Agnon, M. Shalev, E. Keret), Jewish-Russian literature and thought (I. Babel, M. Kagan, Y. Karabchievsky, F. Rosiner, F. Gorenstein, D. Shrayner-Petrov), and Russian-Israeli authors (A. Goldstein, D. Rubina, D. Sobolev, N. Singer, M. Yudson, Elizaveta Mikhailichenko and Yury Nesis and others). His theoretical works are focused on the problems of mythopoesis, chaos theory in literature, generative anthropology (violence and culture), nonverbal communication in literature and culture, sincerity and rhetoric, alternative history, humor and laughter, literary nonconformism.
